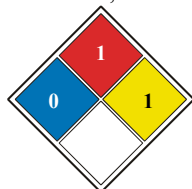

Didecyldimonium Chloride (Cas : 7173-51-5) 0,84% m/m

Benzalkonium Chloride (Cas : 68424-85-1) 0,59% m/m

**Odor:** Characteristic, strong
